PLEASE READ BEFORE PROCEEDING

If you meet any of the following criteria, you will be unable to apply for Preferred Owner status:

- > The dog[s] have not been registered in New Zealand for one full year.
- > The applicant is a probationary owner.
- The dog[s] was first registered after 1 July 2006 and has not yet been microchipped.
- A dog[s] in the care of the applicant has been impounded in the last 12 months.
- Where the applicant has been convicted of any offence, paid any infringement or had an infringement notice referred to the District Court for collection of the infringement under the Dog Control Act 1996 or the Animal Welfare Act 1999 in the last two years.
- A dog[s] in the applicant's care has attacked or bitten any person or animal.
- There has been more than one substantiated complaint against any dog in the possession of the applicant in the last 12 months.
- The applicant lives in an urban area, and has more than two dogs, without a permit.
- ➢ Any dog in the applicant's care is unregistered.

If you fulfil the initial conditions of Preferred Status, please continue with the application.

CRITERIA FOR PREFERRED OWNER STATUS

- 1. The premises where the dog(s) is/are housed has been inspected by a Palmerston North City Council Animal Control Officer and the owner has been interviewed as to their understanding of statute and by-law requirements.
- 2. In the opinion of the Animal Control Officer, the property is adequately fenced to contain the dog[s] at all times.
- 3. In the opinion of the Animal Control Officer the sleeping quarters and exercise facilities for the dog[s] are adequate.
- 4. The owner has not had more than one dog impounded or found at large over the previous 12 months.
- 5. The dog[s] has not been found to be a nuisance to neighbours more than once in the previous 12 months, e.g. complaints for barking or threatening dogs.
- 6. The registration fee/s has been paid by the due date.
- 7. Preferred Owners must notify Council of any change of address within 14 days. A property inspection of the new address is required.

PROPERTY CONSIDERATIONS

- 1. Fencing must be adequate to permit dog[s] to be contained at all times, provide sufficient space for exercise and of a height sufficient to prevent dog[s] from alarming neighbours or passers by.
- 2. Suitable sleeping quarters must provide shelter for the dog but not be detrimental to its health, i.e. is adequately placed for light and air. A minimum standard would be a kennel and appropriate run, although a chain may be considered appropriate in some circumstances.

ANIMAL CONSIDERATIONS

The Animal Control Officers assessment will include the welfare of the dog, public health issues and public nuisance issues including:

- ➤ Vaccination.
- > Prevention of unplanned pregnancies.
- Arrangements for leaving dog[s] unattended.
- > Arrangements while on holiday.
- > Facilities for breeding [if applicable].

- > Arrangements for people entering your property.
- > Arrangements for dealing with faeces.
- > Feeding arrangements and type of food provided.
- Standards of hygiene.
- Access to drinking water.
